Summary of annual assessment visit

Teamara has started childminding again after a break, she will be looking after 3 children and working with a part-time assistant who is familiar with the setting. During the audit there was one child present who was well settled into the setting and enjoying a range of resources and activities. Teamara is pro-active and has put in place all recommendations from previous visits and ideas from training and is keen to provide an excellent service.

Assessment Findings

The Safeguarding and Welfare Requirements:

Teamara meets the safeguarding and welfare requirements, she has appropriate policies in place which she shares with parents and attends e-learning and face to face training to increase her understanding of relevant subjects. Some documentation has the old agency phone number which needs updating, however this does not impact on the setting as Teamara knows the current number. The setting is safe and hygienic and Teamara is aware of how to support children's health through healthy eating and personal hygiene and exercise. Teamara will be working with an assistant and has documentation in place, the assistant has updated training including paediatric first aid.

The childcare environment:

The childcare environment is outstanding, Teamara has increased the interest for children when they are in the seating unit having lunch and the child present had a wide range of stimulating activities and resources to explore. Teamara had the right balance of adult-led and child initiated time during the morning and the child confidently engaged in the provision. When she needed reassurance Teamara was sensitive to her needs and the relationship was warm and caring. Teamara explained how she adapts activities for different age groups such as using a selection of cutting pictures of fruit with with older children and fruit printing for the younger ones. Children's work is displayed, showing them that their work is valued. Teamara takes children out on trips, parks and gardens to extend their understanding of the natural world. Teamara labels objects to increase children's knowledge of vocabulary and repeats children attempts at speech, e.g. during a game of peekaboo. Teamara is getting to know the child well and organised the environment to reflect her interests.

Learning and Development:

Teamara continues to use themes and teaches children through these, such as 'healthy me', the child present is able to direct her own learning and as she explores the environment, Teamara shows her props linked to the theme and names them. Children's next steps are agreed with parents and Teamara takes on board parents requests. Teamara has observation

sheets linked to the EYFS which she uses alongside photographs to show children's progress. Teamara naturally teaches children during play, for example pointing out letters and numbers on the bricks and engages the child's interest well.

Partnership working:

Partnership working remains outstanding, Teamara gains information about the children from the parents, including completing an initial child record form, she completes a daily diary and uses Whatsapp to communicate with parents as well as speaking to parents regularly. Parents write comments in the diary which supports transition and continuity of care. Teamara and parents work well together, for example, exchanging ideas around introducing various food into children's diet.
